Purposes of treatment	Description of the treatment	The purposes that are identified in the Register of treatment activities / Technical data sheet of the company and in the clauses of legitimate, contractual interest or the consent itself, at the foot of each form, being specific for the purpose detailed in the pick up
	Conservation time	The legal provision that requires to preserve them to be kept for fiscal and accounting reasons, and to keep them in order to have them available to a competent public entity. However, more time may be kept for historical or statistical purposes, unless opposition and / or cancellation is exercised.
Recipients	Recipient of the assignment	No data will be transferred to third parties except for legal obligation or contractual interest.
	Purpose of the assignment	No transfer is foreseen, except legal provision.
	Legitimation of the assignment	In accordance with the legal basis of the treatment, in cases of legal obligation, public interest, legitimate interest, contractual interest and the consent of the interested party or his legal representative.
	International data movements	Yes, they occur.

	Treatment processors	The data may be transferred to suppliers with access to data, with whom the obligations and responsibilities assumed in the processing of the data are formalized, as the Data Controller / Custodian of the database.
Rights of the uninterested persons	What rights do I have?	Anyone has the right to obtain information about the treatment of their data. You are entitled to the fact that we confirm you if we are dealing with your data. The interested parties have the right to access their personal data, as well as to request the rectification of the inaccurate data or, in their case, requesting the deletion when, among other reasons, the data are no longer necessary for the purposes that were collected. In certain cases, the interested parties may request the limitation of the treatment, in which case they will be used only for the exercise or defence of claims. In certain cases and for particular reasons, you may object to the fact that we treat your data and we will cease to treat them, unless legitimate reasons or the exercise or defence of possible claims.
	How you can exercise them?	To exercise the rights you must submit a letter at the address above or send a statement to the email info@veterinariadigital.com . You must specify which right you are satisfied with and, in turn, must accompany it with a photocopy of your ID or equivalent identification document. If you act through a legal or voluntary representative, you must also provide a document proving the representation and the identification document thereof.
